## PROJECT SUMMARY

Europe's transition to a climate-neutral continent within 2050 will demand the commitment of all stakeholders, who are asked to pool their resources and expertise to take full advantage of the opportunities offered by low-carbon economy. In addition, over than climate change, transition can incite economic development and energy independence, critical to our security as we have clearly realized. Essential to this approach is turning all citizens from consumers to citizen producers and consumers (prosumers). At the same time, it is necessary to shape properly a kind of business able to meet and face the challenge of renewable energy production, as well as energy efficiency. Energy Communities (ECs) are emerging as a favoured model of cooperation among citizens, civil society, social entrepreneurs, public authorities and community organizations. Enabling them to access to clean energy, at the same time they create job's placements, increasing skills, developing local economy, reducing energy poverty and strengthening community cohesion. "Energy collective" models will be a key tool in the fight against climate change and should be driven from the bottom up. However, national, regional, local authorities and private entities can support the birth of Energy Collective by providing the right framework. Communities can facilitate funding, expertise and advice, ensuring that regulatory issues can be easily understood and managed. GREEN faces the underlying issues related to models of energy collectives in the program area and provides good practices and guidance on the topic drawn from the capitalization of Project ADRIA\_ALLIANCE (ITALME 397).

### Green's approach:

-Developing strategies for involvement in energy transition to encourage proenvironmental behavior by citizens, especially through the role of NGOs

-In addition to providing elements for the implementation of ECs, also technical solutions to make energy consumption more efficient, combating the issue of energy demand.

The Rob.in project implements a regional network of social Labs in the form of



FabLabs composed of Third Sector bodies, local bodies, ecclesial bodies, companies, schools, research centres, to involve minors at risk of early school drop-out/lack of school attendance, particularly those with special educational needs and their families, through the activities and methodologies of inclusive educational robotics, to take them in charge and create the conditions to bring them back to school.

The project aims at providing solutions to educational and social poverty problems affecting minors of the 3 towns of Cerignola, San Giovanni Rotondo and Taranto (more specifically of its old town) and particularly to some fundamental needs of adolescents of the territory, promoting their active participation in positive aggregative initiatives in dedicated spaces and creating the conditions to turn "void times", occupied in the best of cases, in services of commercial nature, but also by mafia and criminal organizations, that take young people as fertile soil for their profits and to increase their illicit activities, into "educational times". The municipal territories, lacking in cultural initiatives, socialization and services dedicated to minors, do not facilitate the full development of their formal, informal and nonformal competences, necessary to build a full and positive personality in youth. Finally, the lack of job opportunities and the scarce inclination to cooperation on the territory determine a further obstacle to adolescents' growth. All this undermines the well-being, hope and perspectives to improve adolescents' conditions that identify as the only alternative for their future the flight from their territory or, and this is even worse, the resignation to the existing situation. The Educating Communities realized and their main operational tools, the social FabLabs, shall increase their capacity to satisfy minors' informal, relational and transversal competences thought tools adapted to new learning needs; increase the possibility to satisfy their social, cultural and relational needs to build the ground for Life Projects based on the enhancement of individual talents, strengthening the listening and relational competences of parents with their children; develop family/school/territory alliances to prevent and fight against educational poverty.

The Project tackled the main common challenges of the programme internal and rural areas: creating new tourist destinations through promotion of natural and cultural heritage; supporting diversification, customization, integration and specialization of local tourist services by focusing on accessibility and sustainability; improving common knowledge of new trends in the tourism market and the marketing capacity of SME and local communities to promote a tourism based on the experience of "new communities"; providing smart systems capable of promoting the best international tourist marketing.

The project overall objective was to promote and strengthen the Accessible and Sustainable tourism offer of the cross border area at a European and international implementation diversification of level. through the and the tourist products/services in the target areas. Accessible tourism consists of all the services and structures that allow people with special needs (e.g. families with children, disabled, senior citizens, people with specific medical conditions, people with food intolerances, people with temporary disabilities, etc.) to satisfactorily enjoy their holiday, with no obstacles or difficulties of any sort, autonomously and in a safe and comfortable way.

The project implemented a new *Cross border Accessible and Sustainable Community Tourist Destination*, able to increase the tourists incoming (in particular people with special needs) and consequentially the promotion of the natural, environmental, historical and cultural heritage, boosting a smart and sustainable economic development in the whole Cross border area. This will lead to turn



Accessible and Sustainable tourism into the development flywheel of the cross border internal/rural areas.

The main outputs realized in the Project are: Cross border Network for A&S Tourism; a model for the Organization of Cross border Destination Management for Accessible & Sustainable Tourism (DMO); Web platform and APP; Valorized sites for tourists and especially for people with special needs. The local rural communities (public authorities, SME, NGO, citizens) have benefitted from these outputs.

The project approach is based on Community-Led Local Development, focused on specific sub-regional areas' needs and assets, aiming to create local hospitality systems by opening rural communities towards new tourist inflows in a cross border framework.

# **OBJECTIVES AND ACTIONS**

The project has experimented a model of social and work inclusion of people under penal execution on the territorial areas of Cerignola and Northern Daunian Mountain, through the establishment, start up and development of a social enterprise that has managed a productive facility in the sector of collection, restoration and maintenance, adjustment and sanification services of prothesic aids for non-self-sufficient people registered in the lists  $1 - 2 \in 3$  of the Ministerial Decree 332/99 and following modifications.

To this end, the Partnership has first of all provided for the functional adaptation of the premises of the Prison of Lucera to realize the "Bottega dell'Ausilio" (Aid Workshop) at the third floor of the Prison where the first productive unit has been realized. The second productive unit, "Officina dell'Ausilio" (Aid Factory), was realized in the Industrial area of Cerignola and it deals with the tasks of collection, restoration and maintenance, adjustment and sanification services of prothesic aids for disabled people, also through the use of two vans. After a training period in classroom and *on the job,* from the 1st of October 2015, n. 3 prisoners of the prison of Lucera were hired as workers under the National Collective Labour Agreement of Social cooperatives and n. 4 people under external penal execution



for the factory of Cerignola, that are summed to the two employees with task of team leaders that have led the training activities on the job.

## THE SERVICE

The implemented productive process is based on a management system to collect, restore and deliver the aids that allows to manage all the phases, from the proposal by the prescribing doctor, to the order by the person in charge of the Local Healthcare agency, to the user's home delivery. The productive process ensures, on an experimental basis, to the ASL FG:

- collection of the old and damaged aids from both the seats of the sociohealthcare Districts of the ASL FG and from the users' homes;
- sorting of the aids according to the pathway they will follow: 1) sanification, adjustment and regeneration; 2) destructuring;
- destructuring of the materials discarded during the process of adjustment, regeneration and sanification;
- maintenance, adjustment, regeneration and sanification services of the collected aids;
- storage service of the collected and processed aids, ready to be delivered to new users upon indication by ASL FG;
- delivery of the processed aids to the users upon indication by ASL FG.

The service, offered on an experimental basis to the ASL FG has allowed the latter to re-use the aids addressed to the users, thus avoiding to buy new ones and allowing to save money and reduce public expenses up to the 70% of the cost borne to purchase new aids. Furthermore, the ASL FG has acquired both a personalized logistic service based on the users' needs (service of collection and delivery of the aid and of the book of instructions and concomitant training to the use of the aid by qualified staff) and a physical storage of the aids in the Factory of Cerignola which it did not have before.

## THE SOCIAL ENTERPRISE

ESCOOP and the private partners of the project Social Cooperative L'Obiettivo and Home Care Solutions, to manage the service described before, have established on 28/10/2015 the social enterprise named INNOVA - Innovazione sociale per l'inclusione Attiva – SOCIETA' CONSORTILE IMPRESA SOCIALE a R.L., that has managed the service in the framework of the Project since 10 March 2016. The private Partnership of the project – strongly supported by the public one – has implemented all the actions needed for the start up and development of INNOVA -Innovazione sociale per l'inclusione Attiva - Società Consortile IMPRESA SOCIALE a R.L.: from the assessment with the ASL FG - based on the results of the experimentation carried out - of the possibility to continue the project activities and more specifically, the experimented service. A Deliberation has followed by the General Drector of the ASL FG n. 512 of 12 May 2016, that gives mandate to the Director of the Rehabilitation Office to carry on for 6 more months the service experimentation that could have been extended for other 6 months. It allowed to organize meetings with representatives of other Apulian Local Health care agencies and other penal institutions to transfer the tested model of social and work



inclusion in the other Apulian provinces with special reference to those of Barletta-Andria-Trani, Bari, Taranto and Lecce.

Since 14 September 2016 INNOVA is carrying out its first order: the maintenance management of the Technical Aids of the ASL FG accoding to the agreement signed on 29/07/2016. After the conclusion of the first period of 6 months, the Agreement has been extended by the ASL FG thanks to the positive results achieved and it is still in force.
